THE POSITION

The Environmental Management Department (EMD) is currently recruiting for an individual with proven expertise and leadership in all CUPA programs, Incident Response, Local Enforcement Agency delegated programs from Cal Recycle, Wells including an Abandoned Wells Program, Septic Tank and Liquid Waste, and Local Oversight Programs.

Experience in Board presentations both oral and written, budgets, fee determinations, and fee collections are critical requirements for the successful candidate.

Within EMD, the Environmental Program Manager I will serve as the Deputy Division Chief for the Environmental Compliance Division and be responsible for an \$11.5 million dollar budget and 54 professional staff.

The position requires an individual who possesses exceptional analytical and strategic thinking skills who stays abreast of current and emerging policies. Experience with Envision software and use of tablet inspections is desirable.

1. Two years of supervisory experience at a level equivalent to the Environmental Specialist IV class within Sacramento County service.

Or:

2. Possession of split off rights as granted by the Civil Service Commission and Board of Supervisors via SRA #90-85.

California certification as a Registered Environmental Health Specialist is desirable but not required. Note: Possession of a Master's Degree from an accredited college or university in health science, public health, natural science, business or public administration, physical science, environmental science, or a related field may substitute for one year of the required supervisory experience.
